We are pleased to accept your submission for publication in *Wild Apples* (the "Magazine"). This agreement outlines the terms and conditions governing your contribution to the Magazine.

### Grant of Rights:

- 1.1 You, the Contributor, retain all copyrights to the work submitted (the "Work").
- 1.2 By submitting the Work to *Wild Apples*, you grant us the non-exclusive right to publish, reproduce, distribute, display, and promote the Work in the Magazine and any related promotional materials.

### Publication:

- 2.1 *Wild Apples* will make grammar, spelling, punctuation, and usage corrections if needed. No changes in content will be made without the written approval of the Contributor.
- 2.2 The decision to publish the Work rests entirely with the editorial staff of *Wild Apples* and is contingent upon the Work's compliance with the Community Standards for Public Art in Londonderry (referenced as Attachment A), which is incorporated into this agreement.
- 2.3 The Work(s) will not appear in any other publication within 30 days of publication in *Wild Apples*.
- 2.4 Publication in *Wild Apples* will occur in a digital and/or print medium.

**Payment:**

3.1 There will be no compensation, monetary or otherwise, for the publication of your Work.

**Attribution:**

4.1 The Magazine will credit you as the Creator of the Work in the byline.

4.2 Any additional credits requested by the Contributor will be considered, subject to editorial approval.

**Promotion:**

5.1 You grant us the right to use your name, likeness, and a brief biography for promotional purposes related to the Magazine.

5.2 Wild Apples may publish quotations or excerpts from the Work on digital/social media sites for the purpose of promotion, unless the Contributor requests otherwise in writing.

**Termination:**

6.1 Either party may terminate this agreement with written notice if the other party breaches any material term of this agreement.

**Miscellaneous:**

7.1 This agreement constitutes the entire understanding between the parties and supersedes any prior discussions or agreements.

7.2 Any amendments to this agreement must be made in writing and signed by both parties.

Please sign and return one copy of this agreement to indicate your acceptance of the terms. Your submission will be considered final only upon receipt of the signed agreement. We reserve the right to terminate acceptance if your signed agreement is not returned within 30 days of the date at the top of this agreement.

### **A. Londonderry Community Standards for Public Art**

As a town chartered committee of Londonderry, New Hampshire, the Londonderry Arts Council (LAC) adheres to the following standards and guidelines for all art we promote, publish, display, host, etc. All submissions to LAC programs are subject to review with these guidelines in mind. LAC reserves the right to decline any submissions to any art programs we support, monetarily or otherwise. All art that is accepted must be:

**Respectful and inclusive:** Artwork must uphold principles of respect, inclusivity, and diversity. It must avoid any content that expresses or promotes discrimination based on race, age, color, sex, national origin, physical or mental disability, sexual orientation, religion or otherwise as may be prohibited by federal and state law.

**Enjoyable for all ages:** Artwork must be family-friendly and able to be enjoyed by people of all ages.

**Safe for public display:** Artwork must not pose any safety risks or hazards to the public area where it is installed.

**Lawful:** Artwork must abide by federal, state, and local historic preservation and environmental laws, regulations, and policies.

**Original:** Artwork must be original and created by the artist or group who is claiming authorship. Art that is plagiarized, copied, or in imitation of another piece will not be considered. Art that is fully AI-generated will also not be considered, although art that interacts with or explores AI in an original manner may be. If any portion of an art piece is AI-generated, this should be disclosed at the time of submission.

LAC reserves the right to change these standards. Depending on the needs of the public art display or publication, selected artists may also need to sign Artist Agreements, Contracts, Waivers, or other documents as necessary.
